**Eligibility:**

***Eligibility Criteria for Foreign National Students to Apply For Postgraduate Courses***

To be successful in interview.

***Eligibility Criteria for the Applicants Who Have Completed Their Undergraduate Studies Abroad***

A: To obtain a "Certificate of Equivalence" from the General Directorate of Higher Education Credit and Hostels Institution.

B: To score at least 60 in TÖMER (Turkish Proficiency Test) or 70 in the exam conducted by the Turkish National Police Academy. Applicants who have completed their secondary school or undergraduate studies in any Turkish School will be exempt from this requirement.

C: Within the framework of bilateral protocols and cooperation agreements, only 1 year at most can be given to achieve the language requirement for those who are coming for the postgraduate course or they can be given a 1 year Turkish Prep Course in Police Academy.

### ***Eligibility Criteria for Foreign National Students to Apply For PhD***

To be successful in an interview.

To have a postgraduate degree with thesis.

### ***Eligibility Criteria for the Applicants Who Have Completed Their Undergraduate Studies Abroad***

A: To obtain a "Certificate of Equivalence" from the General Directorate of Higher Education Credit and Hostels Institution.

B: To score at least 60 in TÖMER (Turkish Proficiency Test) or 70 in the exam conducted by the Turkish National Police Academy. Applicants who have completed their secondary school or undergraduate studies in any Turkish School will be exempt from this requirement.

C: Within the framework of bilateral protocols and cooperation agreements, only 1 year at most can be given to achieve the language requirement for those who are coming for the postgraduate course or they can be given a 1 year Turkish Prep Course in Police Academy.

### ***Requirements and Documents for Those Who Will Be Applying For the Foreign Language Postgraduate Programmes***

1: To have an undergraduate diploma

2: 2 reference letters

3: Motivation letter

4: CV

5: English Sufficiency Document: those who completed their undergraduate programme in a programme where the education language was not English should get pass marks in KPDS, YDS, TOEFL and IELTS. In order to be able to apply for the programme, minimum scores should be 75 in KPDS, ÜDS, or YDS; 550 in TOEFL and 6 in IELTS.

7: For Turkish Citizens, at least 55 from ALES (1100 from GRE)

8: ID or passport or authenticated copy

9: 50 Turkish Liras (during the application)
